"The staff are incredible! They've become extended members of our family with the love, patience, and care they've given all of us." His parents have seen tremendous growth in Caulder, including walking independently.

When asked about Caulder's future, his parents said, "His future is unpredictable, but the uncertainty only lies in all the great things he's going to accomplish!" Caulder truly is a shining star.

New Autism Center Underway Partnership among Autism Services of the Finger Lakes at Happiness House, CP Rochester, and Al Sigl Community of Agencies

A new proposed center for autism services is closer to becoming a reality. With the creation of Autism Services of Monroe County and the expansion of services that it will generate, it is expected that the needs of families dealing with autism will be more effectively addressed. The new center is a partnership among Autism Services of the Finger Lakes at Happiness House, CP Rochester, and Al Sigl Community of Agencies. It will provide an array of services for individuals with Autism Spectrum Disorder (ASD), their families, schools, agency staff, and additional service providers. The primary purpose of the center is to have a central location that provides families access to services and evidence-based practices.

Autism Services of Monroe County will seek to expand and support existing programs in a more cohesive manner in the community. The center will begin in a structure that is up to 26,000 square feet and will have the potential to expand and grow as new needs and opportunities for collaboration present themselves. CP Rochester and the Al Sigl Community of

Agencies will act as the "lead agencies" in developing autism services providing preschool – kindergarten opportunities, respite, community habilitation, an employment connection as well as an Article 28 clinic that will include: occupational, physical and speech therapies, behavioral and and primary care supports. To promote interagency collaboration, different providers will be included in the center through leasable space and shared provision of other services. This interagency collaboration will create a model that addresses lifespan services and minimizes gaps in care.

"CP Rochester and the Al Sigl Community of Agencies are seeking to create an innovative approach to autism services in many ways similar to our partnership founded over 54 years ago. Autism Services of Monroe County will be staffed by professionals from a variety of disciplines with an expertise in serving individuals with ASD," said Mary Walsh Boatfield and Tom O'Connor, President of the Al Sigl Community of Agencies.

CP Rochester and Happiness House Partnering with CDS Monarch

In collaboration with CP Rochester and Happiness House, CDS Monarch opened four satellite Article 16 clinics throughout the Webster and Rochester areas. These clinics offer physical therapy, occupational therapy, and speechlanguage pathology services to individuals with intellectual and developmental disabilities who receive services from CDS Monarch.

Changes in funding from the Center for Medicaid Services and the Office for People With Developmental Disabilities has given the agencies the opportunity to form this partnership and streamline clinical services at these four centralized locations. By opening these locations, individuals recieve enhanced coordination of clinical services.

By partnering with CDS Monarch, our agencies will deliver an enhanced level of therapeutic services to people of all abilities throughout Monroe County. The four satellite clinics are located at the Wolf Life Transitions Center and Webster Creative Opportunities locations in Webster, as well as the Linden Creative Opportunities and Penbrooke Creative Opportunities locations in Penfield.

Rochester Rehabilitation Receives \$4 Million Grant

Department of Labor grant will improve access to career training and placement while supporting working parents with child care during job training

Rochester Rehabilitation was recently awarded a \$4 million grant from the Federal Department of Labor enabling the agency to partner with other organizations and area employers to create access to living-wage jobs, and support career advancement in in-demand industries for parents with dependent children at home. Job training, job placement, career advancement, benefits management, and child support is available.

Rochester Rehabilitation's award is part of a larger \$54 million nationwide grant awarded by the Department of Labor through its Strengthening Working Families Initiative. It is one of 14 in the nation and the only one awarded in New York State. U.S. Senators Charles Schumer and Kirsten Gillibrand were instrumental in securing the funding for Rochester Rehabilitation.

The Employment Connection programs at Rochester Rehabilitation help adults with

disadvantages successfully find and keep jobs through initiatives such as Learning to Achieve by Self-Reliance, Supported Employment, Refugee Employment Services, and others.

Rochester Rehabilitation is the lead agency partnering with the Child Care Council, Action for A Better Community, the United Way of Greater Rochester, and the Workforce Development Institute on this initiative.

As an experienced provider of employment services, Rochester Rehabilitation's Employment Connection has served thousands of people with disabilities and populations with a disadvantage. Their team of employment specialists networks with dozens of local hiring managers in a broad range of businesses to fill vital roles and maximize employer and employee success.

Rochester Rehabilitation, a partner agency of the Al Sigl Community of Agencies, recently

aligned with another Sigl agency, CP Rochester, as part of that agency's passive parent corporation, Ability Partners, Inc. which also includes Happiness House in Ontario County. The addition of Rochester Rehabilitation to Ability Partners Inc. has enhanced the scope of high quality services for all three organizations, provided a larger operational platform, leveraged resources, and enhanced costeffectiveness.

By working together with other organizations, parents will be able to access affordable, quality child care and participate in job training programs offered by Rochester Rehabilitation and compete for better paying jobs.

"Here we go, the 2016 Walk for Autism Awareness. I cannot believe a whole year has passed since the last Walk, so many wonderful things have happened in our lives. Robert was asked to be an Honorary Chair for the Walk this year. WOW! Autism is close to our hearts and is very much a huge part of our lives. We have a passion to educate and bring an awarness to as many people as we can about autism. Autism, in Robert's case, started out pretty difficult. But as I look back over the years and I see where we were and where we are, it humbles my heart.

Robert's story started at the age of one; he spent his first birthday in the hospital with what I thought was just the flu. I assumed all would be well after he was treated and life would go on as normal; however, that was not to be. Our sweet, beautiful, baby boy changed after that hospital stay. He was still beautiful and sweet but he had lost all language and recognition of people who were very familiar to him. Thank God he remembered me. We were guided to Happiness House where Robert received an evaluation and began programming. Without Happiness House, I believe from the bottom of my heart, Robert would not be where he is today. Happiness House worked with Robert starting at 18 months old, and I began educating myself alongside him. I learned as he learned; I

began to understand I was his voice; I needed to become the advocate for him. This seed was planted during our early years at Happiness House.

Over the years, Robert has continued his involvement with Happiness House. The programs they offer allow him to grow in his knowledge of himself, his self worth, his abilities. But his life now has a direction, a path that is becoming clearer. Robert's path with autism had a beginning, a middle, and now a future. Program Helps Students with Disabilities Attend College

CP Rochester partners with Roberts Wesleyan and BOCES 2 in the B.E.L.L. Program



Five students, who just a few years ago wouldn't have necessarily expected to attend college, donned their cap and gown and walked alongside their fellow students at the commencement celebration at Roberts Wesleyan College. These students, Tyler Davis, James Fortin, Mark Houppert, Dalton Letta, and Austin Ritondale are part of an educational program known as the B.E.L.L. Program.

B.E.L.L. (Bridge to Earning, Living, and Learning) is a two-year, inclusive postsecondary certificate program for students ages 18-26 with intellectual and developmental disabilities who are transitioning to adulthood. The program is a partnership among CP Rochester, Monroe 2 Orleans BOCES, and Roberts Wesleyan College.

"We are thrilled to see these young adults, who have worked extraordinarily hard over the past two years, achieve this milestone," said Mary Walsh Boatfield. "We are particularly proud that this is the first year B.E.L.L. participants walked across the stage to receive their diploma along with their fellow graduates. In fact, they led the procession!"

B.E.L.L. students complete college courses and work with undergraduate students who serve as academic coaches and peer mentors. All courses, activities, and work experiences are catered to students' individual career goals and interests. Post-graduation objectives include personal enrichment, independence, and preparation for competitive employment.

"The Golisano Foundation will continue to work closely with agencies such as CP Rochester and Roberts Wesleyan College to improve opportunities for young adults with intellectual and developmental disabilities after graduation from high school," said Ann Costello, Director of the Golisano Foundation. "The B.E.L.L. Program has set the bar for inclusion of students with disabilities very high; we hope others will follow this example."

The B.E.L.L. program partnership began in 2010 thanks to a \$2.5 million grant awarded to the Institute for Innovative Transition. This grant was to be utilized to develop community-wide, post-secondary opportunities for individuals with intellectual disabilities. The grant was funded through the U.S. Department of Education Office of Postsecondary Education Transition, and Postsecondary Program for Students with Intellectual Disabilities. The program is now funded through a combination of agency support, tuition, and Roberts Wesleyan College scholarships.

\$150,000 in Health Information Technology Grant Awards

The Office of Mental Health, in partnership with the Office of Substance Abuse Services and the Office for People With Developmental Disabilities created a onetime \$10 million Non-Profit Behavioral Health/Developmental Disability Providers Health Information Technology Investment Program. This Program was created to support the acquisition of information technology systems, electronic health records, billing systems, or other hardware and any other infrastructure costs associated with the inclusion of behavioral health or developmental disability services in the Medicaid Managed Care benefit package.

CP Rochester, Happiness House, and Rochester Rehabilitation each received an award of \$50,000 to be used toward the acquisition of equipment and electronic health record systems. These initiatives will support Behavioral Health Services within each organization to accomplish several key objectives including:

- Meeting Department of Health e-prescribing requirements
- Enhance scheduling, documentation, and billing systems
- Interlink electronic communication amongst Behavioral Health and other clinic services
- Provide a platform enabling Behavioral Health Services to interlink with the Rochester Health Information Organization
- Provide individuals served with access to a personalized Patient Health Portal

Women's Club of Pittsford Gives \$500

Since its founding in 1984, the Women's Club of Pittsford has been dedicated to charitable, civic, and educational purposes supporting a wide variety of charitable activities. The Club awarded a \$500 grant to CP Rochester to purchase equipment needed to provide quality, individually-focused, after school/wrap-around services. These services are provided to individuals ages 12 to early 30s who are older than those typically served in traditional child care environments but not yet ready or able to be home alone after school or day program. Through the generosity of the Women's Club of Pittsford, we will be able to purchase additional supplies needed to provide developmentally appropriate activities to after school/wrap-around service participants. CP Rochester thanks the Women's Club of Pittsford for their support.

Music to the Ears!

Since 2002, the Gilbert Spirit Fund of the First Unitarian Church of Rochester has provided support to programs and projects that reflect the special interests of Richard and Joyce Gilbert. A key focus area of this fund is to "promote art and music as integral parts of a responsible search for meaning in life." The Fund gifted CP Rochester's Day Habilitation program \$1,000 to purchase musical instruments that will be used to implement a music program designed to enrich the education, sensory, and social aspects of the services we deliver.



Volunteer Helps Make Connection

CP Rochester is the recipient of a \$1,000 gift from Mercantile Adjustment Bureau to be used to further enhance learning opportunities to Day Habilitation participants by providing the equipment necessary to engage in interactive multimedia applications, multiple modality learning, and ready access to on-line information.

As a Day Habilitation volunteer, Mr. William (Bill) Dreitlein noticed a need for equipment and brought to our attention the giving program of his employer, Mercantile Adjustment Bureau. The company has cultivated a culture of giving back to the community; employees voluntarily pool donation resources to support local and national organizations. Rochester Rehabilitation Recieves \$10,000 from United Way for Synergy Efforts






Authors Among Us

Long-Term Employee Reflects on his Life at Rochester Rehabilitation

One of his fondest memories was being given a bike to ride to work

John Hahn is an employee of Rochester Rehabilitation's OneSource Solutions Janitorial Services division. For nearly 30 years, he has been working at the Federal Building in Rochester as part of the long-term contract it has with Rochester Rehab – cleaning bathrooms, vacuuming offices, and emptying trash recepticles. For many of those years, he walked 45 minutes, at 4 o'clock in the morning, to get to work since buses don't run that early. That all changed two years ago when several people who work in one of the offices in the Federal Building John cleans surprised him with a brand new bike and helmet. What used to take 45 minutes now takes less than 15 minutes. John was surprised and grateful at the unsolicited, charitable gift he received from his friends at the Federal Building on that day. It was something that changed his life forever. But that's not the only time John's life was changed for the better.



Not only is John an employee of Rochester Rehabilitation, he is also a program participant. He came to the agency years ago while receiving welfare assistance. Over the last several years John has taken advantage of various services, including benefit counseling, assistance locating safe and affordable housing, and on-going job coaching. His is truly a success story!

Aktion Club in Action



Understanding Where Your Gift Goes

Ability Partners Foundation supports the missions of CP Rochester, Happiness House, and Rochester Rehabilitation, so it is important to understand where monetary and in-kind gifts go once they are given by a donor.

Nearly every gift given to CP Rochester, Happiness House, Rochester Rehabilitation, and Ability Partners Foundation benefits ALL organizations! Monies raised from the two Galas, the *Autism Walk, 5K Run for Fun, Francis 'Ben' Bonafiglia Golf Tournament, Dash to Dash, Bowling to Raise Bucks*, and most other events are accepted by Ability Partners Foundation. This means, by participating in any agency event, your contribution helps **all three** agencies! Now, donors' gifts carry a much greater impact. In addition, general gifts to CP Rochester, Happiness House, and Rochester Rehabilitation throughout the year benefit all agencies.

There are certainly exceptions to the rule. Gifts that are made to a specific program or service at an agency are reserved solely for that agency. For example, if a donor wishes to give \$1,000 to the Happiness House Structured Day Program, Ability Partners Foundation will process the gift and only apply it to that specific program at Happiness House. Where this is typically most prevalent is with in-kind gifts (furniture, food, etc.) but it can happen with monetary gifts as well. In order for this type of *donor designated* gift to occur, the donor must submit the request in writing when making the gift.

When writing a check to benefit CP Rochester, Happiness House, or Rochester Rehabilitation, we ask that you make it out to **Ability Partners Foundation**. However, even if your check is made out to one of the agencies, it will still benefit all three (unless you designate your gift to a specific program or agency).

Thank you for your generosity over the years! Rest assured, CP Rochester, Happiness House, and Rochester Rehabilitation apply good stewardship to any and all gifts given to our agencies. If you would like to make a donation now, you can do so using the enclosed envelope, or visit us on-line.



Ways to Give

Many donors choose to give from their immediate assets such as cash and check (or via credit card). In addition to this type of giving, there are a number of creative ways to provide long-term financial support, such as with a 'legacy' gift. The goal of the Legacy Society is to plan for our organizations' future and set the course for a strategic vision which will carry the agencies forward. Legacy gifts include bequests, charitable gift annuities, charitable remainder trusts, charitable lead trusts, life insurance, real estate, and others.

Every member of the CP Rochester, Happiness House, and Rochester Rehabilitation family has the power to make future change possible. Together, we continue to ensure the long-term sustainability of programs and services for the 6,000 individuals we serve each year.

Legacy Gifts

- Stocks Gifts of stock enable donors to avoid capital gains on the appreciation in market value of the shares.
- Bequests Simple bequests may be made through a donor's will and can specify any dollar amount, percentage, or portion of the estate.
- Charitable Gift Annuity When a donor transfers property (cash, securities, real estate) to our agencies in exchange for a fixed dollar payment during the donor's lifetime.
- Charitable Gift from an IRA Individuals over 701/2 may designate direct contributions from an IRA.
- Charitable Remainder Trust Pays income to the donor or beneficiary for a period of time, after which the property in the trust passes to our agencies.

- Charitable Lead Trusts A charitable lead (income) trust is established when a donor transfers property to a trust, which generally pays interest income to our agencies.
- Life Insurance A gift of life insurance allows a donor to pass on part of his or her estate with minimum cost, maximum benefit, and often an estate tax advantage.
- Real Estate Gifts of real estate include a principal residence, vacation home, farm, commercial property, and land.
